WHEREAS, on October 19, 2017, *nunc pro tunc* October 16, 2017, the Circuit Court of the State of Oregon for the County of Columbia entered of record the General Judgment in *Columbia County v. 2305 Columbia Building, LLC, et al.*, Case No. 17-CV39624; and

WHEREAS, on October 23, 2019, pursuant to that General Judgment, Seller acquired foreclosed real property, including those certain parcels of land situated in Vernonia, Oregon, having Tax Map ID Nos. 4N4W03-BD-01702 and 4N4W03-BD-01703 and Tax Account Nos. 22524 and 22525 (the "Property"), by deed recorded as document number 2019-008826 in the Columbia County deed records; and

WHEREAS, the Property is depicted on Exhibit A hereto, and is more specifically described in the draft quitclaim deed attached as Exhibit B hereto (the "Quitclaim Deed"), which is incorporated by reference herein; and

WHEREAS, the County offered the Property for sale at auction on April 1, 2022, with a minimum bid of \$81,200.00, and no offers were received; and

WHEREAS, pursuant to ORS 275.200(2), the County may sell and convey the Property without further public notice for not less than 15% of the minimum bid at auction; and

WHEREAS, Edward J. Shingle and Deborah L. Shingle ("Buyer") have offered to purchase the Property for \$17,000.00, an amount exceeding 15% of the minimum bid; and

WHEREAS, County policy provides that Buyers of tax foreclosed properties shall pay a \$145.00 administrative fee plus the cost of recording (\$256.00) ("the "Administrative Fee") in addition to the agreed upon purchase price; and

WHEREAS, the County entered into a Purchase and Sale Agreement with Buyer dated May 25, 2022; and

WHEREAS, the County intends to sell the Property to Buyer on the terms and conditions set forth in the Purchase and Sale Agreement.

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1. Pursuant to ORS 275.200(2), the Board of County Commissioners authorizes the sale of the above-described Property to Edward J. Shingle and Deborah L. Shingle for \$17,000.00, plus an administrative fee in the amount of \$256.00.


2. The Board of County Commissioners will convey the Property by Quitclaim Deed in a form substantially the same as Exhibit B.


