WHEREAS, pursuant to ORS 275.200(2), the County may sell and convey the Property without further public notice for not less than 15% of the minimum bid at auction; and

WHEREAS, Buyer has offered to purchase the Property for \$40,100.00, an amount exceeding 15% of the minimum bid; and

WHEREAS, Seller intends to sell the Property to Buyer on the terms and conditions set forth in the Purchase and Sale Agreement.

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1. Pursuant to ORS 275.200(2), the Board of County Commissioners authorizes the sale of the above-described Property to Jason Taylor and Sofia Taylor for \$40,100.00, plus an administrative fee in the amount of \$145.00 administrative fee plus the cost of recording fees in the amount of \$106.00; and

2. The Board of County Commissioners have entered into a Purchase and Sale Agreement with Jason Taylor and Sofia Taylor dated June 1, 2022; and

3. The Board of County Commissioners will convey the Property by Quitclaim Deed in a form substantially the same as Exhibit B; and


