WHEREAS, Buyer has offered to purchase the Property for \$3,480.00, an amount exceeding 15% of the minimum bid; and

WHEREAS, County policy provides that Buyers of tax foreclosed properties shall pay a \$145.00 administrative fee plus the cost of recording (\$101.00) (the "Administrative Fee") in addition to the agreed upon purchase price.

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

- 1. Pursuant to ORS 275.200(2), the Board of County Commissioners authorizes the sale of the above-described Property to Marsh Family LLC Michael T. Marsh Trustee for \$3,726.00, which includes the Administrative Fee.
- 2. The Board of County Commissioners will convey the Property by Quitclaim Deed in a form substantially the same as Exhibit B.


