WHEREAS, on November 8, 2022, Columbia County Administrative School District No. 502 executed and delivered to the County for acceptance a Dedication Deed, a copy of which is attached hereto as Exhibit 1; and

WHEREAS, the right-of-way being dedicated is described in Exhibit A and depicted in Exhibit B of the attached the Dedication Deed; and

WHEREAS, the right-of-way being dedicated abuts Firlok Road and shall be known as "Firlok Road";

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

- 1. The Dedication Deed from Columbia County Administrative School District No. 502, attached hereto as Exhibit 1 and incorporated herein by this reference, is hereby accepted by the County.
- 2. The additional right-of-way as described in Exhibit A and depicted in Exhibit B of the Dedication Deed attached as Exhibit 1 is accepted for public road and utility purposes.
- 3. The dedicated right-of-way shall be known as Firlok Road.


