In the Matter of Approving FY 2025-2026
Solid Waste Collection Rates

ORDER NO. 39-2025

WHEREAS, Section 5.01(A) of the Columbia County Solid Waste Management Ordinance (SWMO) authorizes the Board of County Commissioners (Board), upon its own recommendation or the recommendation of the Solid Waste Advisory Committee (SWAC), to approve and establish rate adjustments; and

WHEREAS, Section 5.01(A)(4) of the SWMO authorizes the Board to increase or decrease rates based on the cost of doing business; and

WHEREAS, Section 5.01(B) of the SWMO requires that prior to approving new rates the Board determine that those rates are just, fair, reasonable, and sufficient to provide proper service to the public. It also identifies factors for the Board to consider in determining if a rate change is justified. Among these factors are:

1. The investment in facilities and equipment; and
2. Local wage scales; and
3. A reasonable rate of return to the franchisee based upon a percentage of gross receipts under the franchise; and
4. The length of haul to disposal facilities; and
5. The cost to the franchisee of the disposal of the solid waste it collects; and
6. Any other factors that in the opinion of the SWAC or the Board impact the rates to be charged; and

WHEREAS, Section 5.04 of the SWMO permits the passthrough to consumers of any increases in disposal fees; and

WHEREAS, Transfer Station disposal rates are adjusted each year based on the prior year CPI. This will result in a 2.2% increase in disposal rates for this coming fiscal year. A table showing the new Transfer Station disposal rates is attached hereto as Attachment A

WHEREAS, the SWAC At-Large Members and County Staff met and reviewed Detailed Cost Reports (DCRs) and proposed rate adjustments submitted by the County's two solid waste collection franchises, Waste Management and Waste Connections; and

WHEREAS, based upon this review it was determined that current rates will not provide Waste Management a reasonable rate of return for the coming fiscal year. SWAC and staff have recommended to the Board that rates for Waste Management customers increase by 5.9% for the fiscal year starting July 1, 2025. These adjustments should assure Waste Management a reasonable rate of return and passes-through to the customers the increase in Transfer Station disposal fees. A table showing the new rates for Waste Management customers is attached hereto as Attachment B; and

WHEREAS, based upon this review it was determined that current rates will not provide Waste Connections a reasonable rate of return for the coming fiscal year. SWAC and staff have recommended to the Board that rates for Waste Connections customers increase by 3.5% for the fiscal year starting July 1, 2025. These adjustments should assure Waste Management a reasonable rate of return and passes-through to the customers the increase in Transfer Station disposal fees.

WHEREAS, Waste Connections has also proposed a change to its rate structure to bring more equity and consistency to rates throughout the three franchise zones they operated. SWAC and staff have recommended to the Board that the revised rate structure be approved. A table showing the new rates for Waste Connections customers is attached hereto as Attachment C; and

WHEREAS, at its meeting of May 21, 2025 the Board scheduled a public hearing on these proposed rates for June 18, 2025; and

WHEREAS, Notice of the June 18, 2025 hearing was properly given by mail and by publication; and

WHEREAS, the Board did hold a hearing on June 18, 2025, to take testimony on the proposed rate changes. At the conclusion of that hearing the Board deliberated on the proposed rate and fee changes.

NOW, THEREFORE, IT IS HEREBY ORDERED, as follows:

1. The Board adopts the above recitals as findings in this matter.
2. The Board of County Commissioners finds that the rate recommendations of the Solid Waste Advisory Committee are just, fair, reasonable, and sufficient to provide proper service to the public. The Board adopts those recommendations as well as the related findings and conclusions of the Solid Waste Advisory Committee as its own.
3. Based upon on the prior year Consumer Price Index, the disposal rates for the County Transfer Station shall be increased by 2.2%. The resulting new rates are shown in Attachment A hereto, which by this reference is incorporated as part of this order.

4. The rates for solid waste collection for Waste Management customers shall be increased by 5.9% for the rural Scappoose and Vernonia service areas. These adjustments includes the pass-through for the increase in the Transfer Station disposal fees. The resulting new rates are shown in Attachment B hereto, which by this reference is incorporated as part of this order.
5. The rates for solid waste collection for Waste Connections customers in the rural Clatskanie, rural St Helens, and rural Rainier service areas shall be increased 3.5%. This adjustment includes the pass-through for the increase in the Transfer Station disposal fees.
6. Waste Connections rate and fee restructuring is also approved. The resulting new rates are shown in Attachment C hereto, which by this reference is incorporated as part of this order.
7. The changes to rates and fees authorized under this Board Order shall take effect July 1, 2025.
