



Program Description:	<p>This program provides a sentencing alternative to the Courts, a local intermediate sanction for Adults on Supervision (AOSs) who have failed to comply with supervision terms, and an alternative to paying rent for AOSs participating in the in-house transitional housing program. It is also used as an option to furlough from the jail and AOSs released under the matrix program. This program provides work experience for AOSs and an opportunity for restorative justice; reconciling with the community at large. Clients have the opportunity to learn prosocial employment skills and teamwork.</p> <p>Daily work crews operate under the direction of the Work Crew Supervisor. The program and related contracts are administered by the Community Services Program Coordinator.</p> <p>Work crews are assigned projects throughout the county in municipal, county, and other locations (i.e., schools cemeteries, parks, roads etc.)</p>

Program Objectives:	<p>Provides a non-custody sentencing alternative for the releasing authorities.</p> <p>Provides a cost effective work force to community agencies.</p> <p>Provides an opportunity for AOSs to work in lieu of financial obligations. Program Name:	Electronic Monitoring Program
Program Description:	<p>The Electronic Monitoring Program, managed by our Community Services Program Coordinator, provides allows parole/probation officers an alternative to a jail custodial sanction when addressing violation behavior and to augment traditional supervision by increasing surveillance of higher risk Adults on Supervision (AOS). The program offers two types of monitoring units, a Global Positioning System (GPS) and a remote alcohol testing system. These units allow for general location through passive and active GPS, general compliance with conditions of supervision and remote alcohol testing.</p> <p>The Columbia County Community Justice Department contracts with BI Incorporated for use and monitoring of the GPS and alcohol monitoring devices. The Community Services Program Coordinator and Administrative Case Specialist will review and monitor tracking and testing with BI TotalAccess software which is managed by BI Incorporated.</p>

Program Description:	Columbia County Justice Reinvestment Program (CCJRP) is a collaborative, research informed program aimed to reduce recidivism and prison populations while increasing public safety and accountability for Adults on Supervision (AOS). Through appropriate assessments (Level of Service Case Management Inventory LSCMI and Woman's Risk and Need Assessment WRNA), referrals, and integral delivery of services in and out of custody, this program is designed to increase public safety, reduce JII recidivism, while reducing prison sentences and jail utilization. The CCJRP is aimed at serving high risk/high need AOSs under community supervision

Program Objectives:	Promote public safety, responsibly reduce prison utilization, Increase AOS accountability, Reduce recidivism			
Method(s) of Evaluation:	<p>Quarterly meetings will take place and the status of the program will be presented to the Sheriff, District Attorney and Director of Community Justice. These meetings provide a dedicated time for the department heads to interface with the assigned CCJRP Team to collaborate and address any organizational or system concerns and consider any changes or adaptations as a team. Specific items included in the report: total participants, total applications, acceptances, denials, total prison time departed, revocations, number and nature of sanctions, graduations, schooling/employment status, services, treatment dosage and type provided to participants and recidivism rates for program participants.</p> <p>The Local Public Safety Coordinating Council (LPSCC) serves to identify cost-effective strategies throughout the public safety continuum in Columbia County. The Justice Reinvestment Program outcomes report will be submitted to LPSCC on a semi-annual basis to evaluate the effectiveness of the program, receive community feedback, and increase community collaboration to maintain a high level of community accountability.</p>

Program Description:	<p>Community Supervision of Adults on Supervision (AOSs) placed on formal supervision by the Courts or transferred into Columbia County, Department of Correction prison releases, and Short Term Transitional Leave (STTL) of Adults in Custody (AICs). AOS will be assessed using evidence based tools, by trained staff, for guidance in determining risk level, criminogenic needs, and needs based upon specialized assessments. Program Description:	Transition services will be provided to incarcerated Adults on Supervision (AOSs) to assist in successful transition from custody to the community. This includes direct financial assistance for the purchase of food, transportation, work clothing, crisis, and transition housing; as well as services to assist in the development of a release plan tailored to the AOSs needs. Linking AOSs early on to frontload services and increase chances of access to limited resources, such as affordable housing stock, is an important element of successful integration into the community. Release planning involves pre-planning and reach-in services prior to the AOSs release from prison or jail, coordination of services and collaboration with other county agencies and community partners. The Community Services Program Coordinator will review the AOS for appropriate placement into the in-house transitional housing program. These clients will be required to submit to random alcohol and substance abuse testing, random searches, mandatory curfew, employment search, and household chores. Participation in Work Crew to offset rent is offered to AOSs. This service is offered to assist AOSs without a residence.
