In the Matter of Rate Adjustments for
Curbside Collection Services for Franchised
Haulers in Rural Columbia County and for
Disposal Rates at the Columbia County
Transfer Station

ORDER NO. 24-2026

WHEREAS, Section 5.01(A) of the Columbia County Solid Waste Management Ordinance (SWMO) authorizes the Board of County Commissioners (Board), upon its own recommendation or the recommendation of the Solid Waste Advisory Committee (SWAC), to approve and establish rate adjustments; and

WHEREAS, Section 5.01(A)(4) of the SWMO authorizes the Board to increase or decrease rates based on the cost of doing business; and

WHEREAS, Section 5.01(B) of the SWMO requires that prior to approving new rates the Board determine that those rates are just fair, reasonable, and sufficient to provide proper service to the public. It also identifies factors for the Board to consider in determining if a rate change is justified. Among these factors are:

1. The investment in facilities and equipment; and
2. Local wage scales; and
3. A reasonable rate of return to the franchisee based upon a percentage of gross receipts under the franchise; and
4. The length of haul to disposal facilities; and
5. The cost to the franchisee of the disposal of the solid waste it collects; and
6. Any other factors that in the opinion of the SWAC or the Board impact the rates to be charged; and

WHEREAS, the unincorporated portions of Columbia County is served by two solid waste collection providers, Waste Management for the Vernonia and Scappoose Rural Areas, and Waste Connections for the Clatskanie, Rainier and St Helens Rural Areas; and

WHEREAS, the SWAC At-Large Members and County Staff met and reviewed Detailed Cost Reports (DCRs) and proposed rate adjustments submitted by these two solid waste collection providers; and

WHEREAS, at the Board of Commissioners meeting of June 17, 2026 staff briefed the Board on recommended changes to tipping fees at the Transfer Station and the rates charged by Waste Management and Waste Connections; and

WHEREAS, those recommendations included a greater than CPI increase in Transfer Station fees, including a 7% increase in the Self-Haul disposal fee for loads over 320 pounds and 14% increase in the Franchise Agreement Tipping Fee; and

WHEREAS, Staff and SWAC also recommend that the rates for Waste Management customers increase by 9.7% and that rates for Waste Connections customers increase by 1.83%. These increases were needed to pass through to customers the increases in Transfer Station fees and to assure franchise operators a reasonable rate of return for the fiscal year starting July 1, 2026; and

WHEREAS, Following this staff briefing the Board scheduled a public hearing on these proposed rates for July 1, 2026; and

WHEREAS, Notice of the public hearing was properly given by mail and by publication; and

WHEREAS, the Board did hold a hearing on July 1, 2026, to take testimony on the proposed rate changes. At the conclusion of that hearing the Board delayed deliberation on the proposed rate and fee changes to permit further review with staff. and

WHEREAS, in a memo dated July 10, 2026 Staff proposed that the Transfer Station fee increase be limited to the CPI adjustment provided for under Board Order 6-2010 resulting in a 3.1% increase across the board in Transfer Station fees. A table showing the proposed new Transfer Station fees is attached hereto as Attachment A; and

WHEREAS, As a result of this reduction in the in Transfer Station Rates SWAC and staff have recommended to the Board that rates for Waste Management customers increase by 6.6% and for Waste Connections customers 1.83%. These increases are for the fiscal year starting July 1, 2026; and

WHEREAS, on July 15, 2026 the Board meet and deliberated on this matter.

NOW, THEREFORE the Board Finds as follows:

1. The Board adopts the above recitals as findings in this matter.
2. The Board of County Commissioners finds that the rate recommendations of the Solid Waste Advisory Committee as amended by the Staff Report dated July 10, 2026 are just, fair, reasonable, and sufficient to provide proper service to the public. The Board adopts those recommendations as well as the related findings and conclusions of the Solid Waste Advisory Committee as its own.

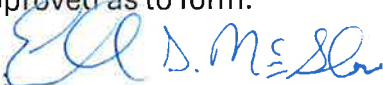
Based upon these findings, IT IS HEREBY ORDERED, as follows:

1. Based upon the prior year Consumer Price Index, the disposal fees for the Columbia County Transfer Station shall be increased by 3.1%. The resulting new fees are shown in Attachment A hereto, which by this reference is incorporated as part of this order.
1. The rates for solid waste collection for Waste Management customers shall be increased by 6.6% for the rural Scappoose and rural Vernonia service areas. These adjustments includes the pass-through for the increase in the Transfer Station disposal fees. The resulting new rates are shown in Attachment B hereto, which by this reference is incorporated as part of this order.
2. The rates for solid waste collection for Waste Connections customers in the rural Clatskanie, rural St Helens, and rural Rainier service areas shall be increased 1.83%. This adjustment includes the pass-through for the increase in the Transfer Station disposal fees. The resulting new rates are shown in Attachment C hereto, which by this reference is incorporated as part of this order.
3. The changes to the Waste Management and Waste Connections rates are effective August 1, 2026. The change in Transfer Station fees is effective July 15, 2026.

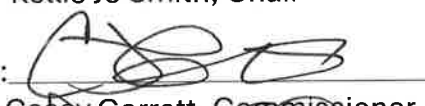

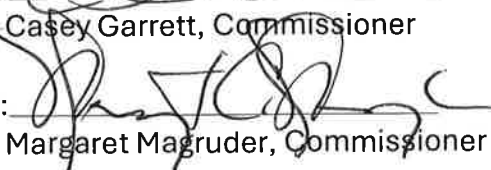
