ORDER NO. 25-2026

WHEREAS, the Columbia County Surveyor has determined that the item of County-owned property listed in Exhibit A, attached hereto and incorporated herein by this reference (a 2009 Chevrolet Silverado pickup truck, VIN No. 1GCEC14089Z128847, with work canopy, referred to herein as the "Vehicle"), is no longer needed for use by the Surveyor's Office and should be declared surplus and disposed of in accordance with the Columbia County Public Contracting Rules (Ordinance No. 2024-2, as amended); and

WHEREAS, the item listed in Exhibit A has an estimated current market value of approximately \$6,000.00; and

WHEREAS, under the Columbia County Public Contracting Rules (Ordinance No. 2024-2, as amended) (the "Public Contracting Rules"), items that the County no longer needs may be declared surplus and disposed of by certain approved methods; and

WHEREAS, the Public Contracting Rules authorize transfer to another County department; and

WHEREAS, the Surveyor has determined that another County department is able to put the Vehicle to further use; and

WHEREAS, the Surveyor proposes offering the Vehicle to the Columbia County Forest, Parks and Recreation Department for its use;

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS HEREBY ORDERS:

1. The property identified in Exhibit A is declared surplus to the County's needs.
2. The Surveyor is hereby authorized to cause the transfer the property identified in Exhibit A to the Columbia County Forest, Parks and Recreation Department.

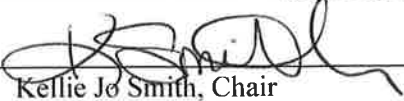

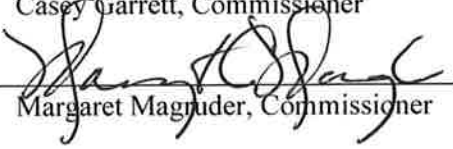

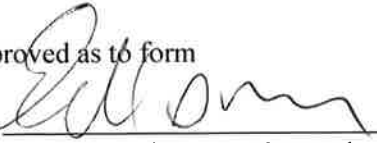
