ORDER NO. 109-2000

WHEREAS, the Columbia County Public Event Ordinance became effective on July 2, 1997; and

WHEREAS, pursuant to the ordinance, persons who want to conduct a public event are required to apply for a permit and make a deposit in an amount estimated to cover the cost impacts of the public event to public agencies in the County; and

WHEREAS, Robert J. Foote, Jr., President, Hood-to-Coast Relay, applied for and received a permit to conduct the Hood-to-Coast Relay, Portland-to-Coast Walk and Portland-to-Coast High School Challenge through Columbia County on August 25 and 26, 2000, and, through Foote Sports Productions, Inc., made a deposit of \$20,400 toward the impact costs to public agencies; and

WHEREAS, the Board has received and approved applications for cost reimbursements from the following agencies in the following amounts:

WHEREAS, upon request, the Hood-to-Coast Relay tendered an additional \$3,950.07 to cover the impact costs outlined above.

NOW, THEREFORE, IT IS HEREBY ORDERED AS FOLLOWS:

1) The Columbia County Treasurer is directed to issue checks to the public agencies listed above in the amounts shown for their costs incurred as a result of the Hood-to-Coast Relay, Portland-to-Coast Walk and Portland-to-Coast High School Challenge through Columbia County on August 25 and 26, 2000; and

2) The Columbia County Treasurer is directed to issue a check in the amount of \$415.25 made payable to Hood-to-Coast Relay, c/o Robert Foote, Jr., President, Foote Sports Productions, Inc., 5319 SW Westgate Dr., Suite 262, Portland, OR 97221.
