WHEREAS, the items of County owned personal property on the attached Exhibit have been determined to be no longer of use by the County; and

WHEREAS, OAR 125-350-025, adopted by reference by Ordinance No. 88-3, allows for the transfer of personal property, without remuneration or only nominal remuneration without competitive bids to another public agency; and

WHEREAS, the Science Department of Clatskanie High School, Clatskanie School District, uses donated personal property in its science program and specifically uses computers and related items in its computer science program;

WHEREAS, the Vernonia High School, Vernonia School District, can use donated computers and related items in its classrooms.

NOW, THEREFORE, IT IS HEREBY ORDERED that the items of County owned personal property listed in the attached exhibit are declared surplus to the County's needs, and that those items be transferred as listed to the Clatskanie and Vernonia School Districts.
