WHEREAS, on April 14, 1993, the Board of County Commissioners for Columbia County adopted Ordinance No. 93-4 which in turn adopted the "Columbia County System Development Charge Ordinance" effective July 1, 1993; and

WHEREAS, pursuant to Section IV.A of the System Development Charge Ordinance, the Board established the Parks and Recreation SDC Account to hold funds generated from systems development charges for the purpose of providing capital improvements related to parks and recreation which provide for increased capacity necessitated by development; and

WHEREAS, pursuant to Section IV.D of the System Development Charge Ordinance, any capital improvement being funded wholly or in part with system development charges revenue shall be included in the County's capital improvement plan; and

WHEREAS, the capital improvement plan developed pursuant to the System Development Charge Ordinance included various projects such as the Beaver Boat Ramp and the Gilbert River parking lot, floats and boat ramp; and

WHEREAS, on April 6, 1994, the Board adopted Ordinance No. 94-4 which repealed Ordinance No. 93-4 effective April 6, 1994; and

WHEREAS, Section 6 of Ordinance No. 94-4 directed the Columbia County Treasurer to refund all system development charges paid on or after March 23, 1994; and

WHEREAS, there is remaining in the Parks and Recreation SDC Account \$13,551.01 from system development charges paid prior to March 23, 1994; and

WHEREAS, the Beaver Boat Ramp was completed at a cost of \$84,055, some of which was funded out of the Columbia County Parks Cash Account; and

WHEREAS, the Gilbert River project was completed at a cost of \$208,669, some of which was funded out of the Parks Cash

Account; and

WHEREAS, the amount of money paid out of the Parks Cash Account, not already reimbursed, for capital improvement projects included in the capital improvement plan far exceeds the remaining \$13,551.01 in the Parks and Recreation SDC Account and it would be appropriate to reimburse the Parks Cash Account in the amount of \$13,551.01 for its costs in constructing these capital improvement projects;

NOW, THEREFORE, IT IS HEREBY RESOLVED to transfer \$13,551.01 from the Parks and Recreation SDC Account (202-00-00-1004) to the Parks Cash Account (202-00-00-1001) as partial reimbursement for capital improvement projects that were constructed pursuant to the capital improvement plan developed pursuant to the Columbia County System Development Charge Ordinance.
