THIS MATTER having come before the Board of County Commissioners of Columbia County, Oregon sitting as the governing body of the Columbia County 4-H and Extension Service District on the 30th day of June, 2000; and

WHEREAS, the Columbia County 4-H and Extension Service District Budget Committee approved the budget for the district for fiscal year 2000-2001 on May 17, 2000; and

WHEREAS, the Board of County Commissioners sitting as governing body of the district has received the budget and made any necessary modifications and the same is now ready for adoption;

NOW, THEREFORE, IT IS HEREBY RESOLVED that the 2000-2001 budget for the district in the total amount of \$454,745 be, and hereby is, adopted; and
