THEREFORE, IT IS HEREBY ORDERED that the name of the Columbia County Recycling and Garbage Service solid waste collection franchise is hereby changed to Waste Management of Oregon, Inc., effective on the date of this order.

Dear Sir or Madame:

This letter is a request for the Board of Commissioners of Columbia County to approve a merger between Columbia County Recycling and Garbage Service and USA Waste of Oregon, Inc., now Waste Management of Oregon, Inc. Waste Management of Oregon assumed ownership of Columbia County Recycling and Garbage Service as well as Nehalem Valley Sanitary Service on January 1, 1999. Waste Management is now consolidating all subsidiaries into Waste Management of Oregon, Inc.

On December 17, 1986, the Board of County Commissioners approved a solid waste management ordinance. Section 4.16 of the ordinance provides for Board approval for transfer of the franchise as follows:

A franchisee may transfer his franchise or a portion thereof, to other persons only upon written notice to, and approval by the Board and after the Board has received a recommendation and finding by the Committee approving said transfer.

Upon recommendation and finding by the Committee, the Board shall approve the transfer if it finds that the transferee meets all applicable requirements met by the original franchise holder.

On June 24, 1998, the Board of County Commissioners for Columbia County approved a seven-year franchise to Columbia County Recycling and Garbage Service to provide garbage collection and recycling services in the Scappoose area.

On September 20, Columbia County Board of Commissioners approved Order No. 95-00, for a change for the Nehalem Valley Sanitary Service franchise for service in Columbia County Vernonia and Scappoose areas to USA Waste of Oregon, Inc. This letter is a request for the Board of Commissioners of Columbia County to approve a merger between Columbia County Recycling and Garbage and USA Waste of Oregon, Inc. now Waste Management of Oregon.
