ORDER NO. 2-01

WHEREAS, members of the Columbia County Fair Board are appointed by the Board of County Commissioners pursuant to ORS 565.210(2) and Article II, Section 2, of the Columbia County Fair Ordinance; and

WHEREAS, pursuant to ORS 565.210(2), terms of Fair Board members expire in January and, after the initial appointment of Fair Board members, "[a]nnually thereafter, at the first meeting in January, upon the expiration of the term of a member, a successor shall be appointed to serve for three years"; and

WHEREAS, currently, terms of members of the Fair Board are scheduled to expire on January 31, in the third year after appointment; and

WHEREAS, County Counsel has advised that, to meet the requirements of the statute with regard to reappointment, terms should expire in January prior to the first meeting of the Board of Commissioners; and

WHEREAS, the terms of current members of the Fair Board, and recently appointed members of the Fair Board should be adjusted to reflect the requirements of the statute;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1. The terms of current members of the Columbia County Fair Board, and recently appointed members of the Fair Board, should be adjusted according to the attached table which is labeled Exhibit "A" and is incorporated herein by this reference.

2. The terms of persons appointed to be members of the Fair Board in the future shall be for approximately three years expiring


on the first day of January of the year of expiration.

3. In the event a member resigns or otherwise vacates his or her membership on the Fair Board, a replacement member shall be appointed to fill the remaining unexpired term of the member.

4. This order is effective February 1, 2001.
