ORDER NO. 21-2001

WHEREAS, Vista Lane is a private road; and

WHEREAS, pursuant to Final Order MP 98-52, before further development will be allowed on Vista Lane, the road must be dedicated to the public for road and utility purposes as a local access road only, and improved to the current county road standards; and

WHEREAS, the property owners along Vista Lane have agreed to dedicate the needed property to the County for road and utility purposes forever; and

WHEREAS, on February 3, 2001, Michael W. Stone and Ronald R. Peterson, on behalf of Stone Builders, Inc., an Oregon corporation, Robert C. Thompson and Mary J. Thompson, husband and wife, and Dale H. Lammers and Delrae L. Lammers, husband and wife, executed and delivered to the County for acceptance a Dedication Deed, a copy of which is attached hereto, labeled Attachment 1 and incorporated herein by this reference; and

WHEREAS, the desire and intent of the above-named parties is to dedicate Vista Lane in area of St. Helens, Oregon, to the public for road and utility purposes forever; and

WHEREAS, a legal description of the property being dedicated as Vista Lane, prepared by Dewey Surveying, Inc., is attached as Exhibit A to the Dedication Deed; and

WHEREAS, a survey map of the property being dedicated as Vista Lane prepared by Dewey Surveying, Inc., is attached as Exhibit B to the Dedication Deed; and

WHEREAS, the Columbia County Roadmaster recommends that the property being dedicated as Vista Lane be accepted into the Columbia County Road System, as a Local Access Road only, a copy of which recommendation is attached hereto, labeled Attachment 2 and incorporated herein by this reference;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1. These proceedings are initiated pursuant to ORS 368.073.

2. The Dedication Deed from Michael W. Stone and Ronald R. Peterson, on behalf of Stone Builders, Inc., an Oregon corporation, Robert C. Thompson and Mary J. Thompson, husband

and wife, and Dale H. Lammers and Delrae L. Lammers, husband and wife, is hereby accepted by the County, as a Local Access Road only.

3. The property being dedicated as Vista Lane in the St. Helens, Oregon, area, as described on Exhibit A of the Dedication Deed and shown on the survey map attached as Exhibit B to the Dedication Deed, is accepted for public road and utility purposes as a Local Access Road only, and not as a County road.

4. The Dedication Deed and this Order shall be filed with and recorded by the County Clerk without cost.

5. The attached survey shall be recorded with the Columbia County Surveyor without costs.
