ORDER NO. 34-01

WHEREAS, Columbia County Forest Parks and Recreation Rules and Regulations prohibit the use of firearms, bows and arrows, and other weapons in any County Park, including Camp Wilkerson, except with permission of the Board of County Commissioners; and

WHEREAS, LDS Young Women's Group have applied for a permit to hold its annual camp group meeting for girls twelve to seventeen at Camp Wilkerson from June 18 through June 23, 2001; and

WHEREAS, the Group has requested permission to provide an archery and BB Gun range with adult supervision during their stay at Camp Wilkerson, a copy of which is attached hereto as Attachment 1, and is incorporated herein by this reference; and

WHEREAS, the Group has agreed to sign a hold harmless agreement, indemnifying the County for any injury to person or property arising from its activities during its stay at the camp; and

WHEREAS, the Group has given assurances that any use of bows and arrows or BB guns will be well supervised, and done safely;

NOW, THEREFORE, it is hereby ordered as follows: Columbia County grants permission to the LDS Young Women's Group to use bows and arrows and BB guns at Camp Wilkerson from June 18<sup>th</sup> through June 23<sup>rd</sup>, 2001, according to the Group's request.

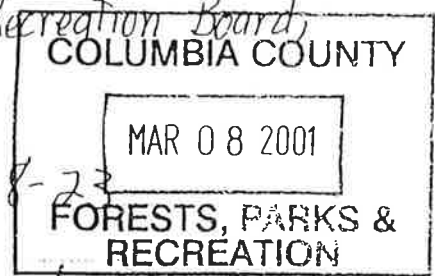

I am writing to request permission to provide an Archery and BB Gun range for our Young Womens camp.

This will be our 6<sup>th</sup> year at Camp Wilkerson. We have exclusive use of the camp and will have an adult to youth ratio of 3 adults to 12 kids. The age range of our girls is 12 years to 17 years old. We have done this the past 5 years.

As in years past, safety is our number 1 concern. We would set up the range where the new ampitheater is going in. Bales of straw, at least 4 bales high, will be secured up against a hillside with no camp, road or trail behind them. The times of operation would be from 9am to 12 noon and 1:30 - 3:00 p.m. The BB Guns and Bows and Arrows will be locked up safe when not in use.
