# AMENDED RESOLUTION NO. 45-01 (Initiating Vacation Proceedings)

[Godsey Petition]

WHEREAS, pursuant to ORS 368.341(1) the Board of Commissioners for Columbia County, Oregon may initiate proceedings to vacate property under ORS 368.326 to 368.366; and

WHEREAS, Gerald R. and Cindy K. Godsey own property abutting a portion of an unnamed, unconstructed road or alleyway lying adjacent to the plat of Neer City near Goble, Oregon, which is proposed to be vacated, and filed with the Board on or about May 7, 2001, a petition requesting that the Board vacate said unnamed road or alleyway; and

WHEREAS, a copy of such petition is attached hereto, labeled Exhibit A, and is incorporated herein by this reference; and

WHEREAS, by Order No. 45-01, this Board initiated proceedings for the vacation of the unnamed road or alleyway described above, said proceedings to be held without a hearing; and

WHEREAS, the Public Works Department subsequently determined that there were additional abutting property owners whose consent to vacate said unnamed road or alleyway had not been obtained; and

WHEREAS, Gerald and Cindy Godsey advised Columbia County that they would take steps to secure the additional consents needed; and

WHEREAS, the Godseys have now advised that they are unable to obtain 100 percent of the required signatures of the owners of land abutting the property proposed for vacation and desire to proceed with the vacation proceedings through a hearing; and

WHEREAS, Mr. and Mrs. Godsey seek vacation of a portion of this unnamed road or alleyway lying between other parcels owned by them to assist in meeting the fire safety zone standards outlined in the Columbia County Zoning Ordinance; and

WHEREAS, that portion of the unnamed road or alleyway proposed to be vacated by the Godseys is generally described as lying between properties commonly described as Tax Account Nos. 6202-000-01300 and 6211-011-00100 on the west, and Tax Account Nos. 6212-022-00801 and 6212-022-00900 on the east, all of said property being owned by Mr. and Mrs. Godsey, and beginning at the southerly section line of Section 2, Township 6 North, Range 2 West, and running in a southerly direction to the northern line of Neer City Road; and,

WHEREAS, at the request of the Public Works Department and for general mapping purposes, the Board of County Commissioners hereby petitions for the vacation of the entire unnamed road or alleyway, to include that portion lying south of Neer City Road; and

WHEREAS, maps further identifying the unnamed road or alleyway proposed to be vacated are attached as Exhibit B and are incorporated herein by this reference, with that area proposed to be vacated by the Godseys lying to the north of Neer City Road identified by slash marks and the area intended to be vacated by the Board of County Commissioners lying south of Neer City Road completely filled in ; and

WHEREAS, the petition submitted by Mr. and Mrs. Godsey complies with the Petition requirements of ORS 368.341(3); and

WHEREAS, it appears that 100 percent of the abutting property owners have <u>not</u> petitioned nor consented to the vacation of this unnamed road or alleyway; and

WHEREAS, prior to the Board's making the final determination on the matter, ORS 368.346 requires the County Roadmaster to prepare and file with the Board a written report containing a description of the ownership and uses of the property proposed to be vacated and an assessment by the County Roadmaster of whether the vacation would be in the public interest; and

WHEREAS, prior to the Board's making the final determination on the matter, ORS 368.346 requires a time and place for a hearing be established to consider whether the proposed vacation is in the public interest;

WHEREAS, this amended resolution is necessary in order to initiate the vacation proceedings by requiring a hearing before the Board of County Commissioners as well as to augment the request for vacation by including that portion of the unnamed road or alleyway lying south of Neer City Road;

NOW, THEREFORE, IT IS HEREBY ORDERED, as follows:

1. The Board hereby initiates vacation proceedings for the unnamed road or alleyway lying adjacent to the plat of Neer City near Goble, Oregon, as described on Exhibit A and shown on Exhibit B.

2. The Board of County Commissioners declares the intent to vacate that portion of the unnamed road or alleyway lying south of Neer City Road as shown on Exhibit B;

3. The County Roadmaster is directed to prepare and file with the Board of County Commissioners a report containing the following:

(a) A description of the ownership and uses of the property proposed to be vacated;

(b) An assessment by the County Roadmaster of whether the road vacation would be in the public interest; and

(c) Any other information the Board may require.

4. The Board of County Commissioners will hold a public hearing on February 25, 2004, at or after 10:00 a.m. in the Commissioners' Meeting Room, Room 308, Columbia County Courthouse, St. Helens, Oregon, to consider whether the proposed vacation is in the public interest.

5. Notice of the hearing shall be provided under ORS 368.401 to 368.426 by posting and publication, and by service on each person with a recorded interest in any of the following:

- (a) The property proposed to be vacated;
- (b) An improvement constructed on public property proposed to be vacated; and
- (c) Real property abutting public property proposed to be vacated.

6. During or before the hearing, any person may file information with the Board that controverts any matter presented to the Board in the proceeding or that alleges any new matter relevant to the proceeding.
