WHEREAS, the Columbia County Public Event Ordinance became effective on July 2, 1997; and

WHEREAS, pursuant to the ordinance, persons who want to conduct a public event are required to apply for a permit and make a deposit in an amount estimated to cover the cost impacts of the public event to public agencies in the County; and

WHEREAS, David Douglas, STP Director, Cascade Bicycle Club, Seattle, Washington, applied for and received a permit to conduct the Seattle-to-Portland Bicycle Classic ("STP") on July 10 and 11, 1999, July 8 and 9, 2000, and on July 7 and 8, 2001; and

WHEREAS, in conjunction with these events, David Douglas remitted the following deposits toward the costs of impact to affected public agencies, and the affected agencies have requested reimbursement of the following amounts due to the impact of these public events:

WHEREAS, County Counsel has advised that the costs incurred by the Scappoose Police Department are not allowable expenses under Ordinance No. 97-6, the Columbia County Public Event Ordinance, which has no jurisdiction over Cities within the County; and

WHEREAS, the Board has received and approved the applications from the 9-1-1 Communications Center for cost reimbursements as outlined above, and approves reimbursement to this agency for the costs of the STP impact for the years 1999, 2000 and 2001; and

WHEREAS, total deposits made by David Douglas for the STP events held in 1999, 2000 and 2001 were \$2,594.97, and impact costs to the 9-1-1 Communications Center for these three years totaled \$647.81;

NOW, THEREFORE, IT IS HEREBY ORDERED AS FOLLOWS:

1) The Columbia County Treasurer is directed to issue a check to the following public agency in the amount shown for its costs incurred as a result of the Seattle-to-Portland Bicycle Classic held in 1999, 2000 and 2001 out of the deposits paid by David Douglas in 1999, 2000 and 2001:
