ORDER NO. 84-01

WHEREAS, ORS 311.795 allows the Board of County Commissioners to cancel all delinquent real and personal property taxes, interest and penalties due thereon from any taxpayer where the total of the same is less than \$5.00 when, in the judgment of the Board, the cost of collecting the same will be greater than the amount to be collected; and


WHEREAS, Ruth M. Baker, Columbia County Tax Collector, has filed a request with the Board to cancel all delinquent real and personal property taxes, interest and penalties in a total of less than \$1.00 from the taxpayers shown on the attached Exhibit "A" which is incorporated herein by this reference; and

WHEREAS, it appears that the cost of collecting the same would exceed the amount to be collected;

NOW, THEREFORE, IT IS HEREBY ORDERED that the delinquent real and personal property taxes, interest and penalties shown on the attached Exhibit "A" be, and hereby are, cancelled.
