In the Matter of Conveying Certain County Owned Real Properties to the City of Clatskanie

ORDER NO. 102 - 2002

WHEREAS, ORS 271.310(1) authorizes Columbia County to sell, exchange, convey or lease their interest in certain real property not needed for public use to any governmental body whenever the public interest may be furthered, the consideration for such transfer being cash or real property, or both; and

WHEREAS, Clatskanie City Manager, Preston Polasek, advised that the City had accepted the Board of County Commissioners' offer to transfer title to four parcels of County-owned property located within the City limits to the City of Clatskanie; and

WHEREAS, the four County-owned parcels are described and given a current assessed value as follows:
