WHEREAS, on December 30, 1981, by Order No. 163-81, the Columbia County Board of Commissioners accepted a quitclaim deed from Clyde Rollins, Maxine Rollins, Charles Huntley and Lois Huntley transferring their interest in the property commonly referred to as Tax Account No. 4105-033-02401 and more fully described in the attached documents, said Order and quitclaim deed being attached hereto as Exhibits A and B, respectively, and by this reference incorporated herein; and

WHEREAS, a survey and map depicting the property to be dedicated are attached hereto as Exhibits C and D, respectively, and by this reference are incorporated herein; and

WHEREAS, Columbia County acquired this property for public right-of-way purposes to facilitate the reconstruction and reconfiguration of the intersection of Gable and Bachelor Flat Roads, but has not yet dedicated the property for public right-of-way purposes; and

WHEREAS, said reconstruction and reconfiguration has been completed; and

WHEREAS, it is necessary to dedicate the acquired real property to the public for right-of-way purposes to ensure that the assessor's mapping will accurately incorporate the property into the public road right-of-way; and

WHEREAS, Dave Hill, Public Works Director, has recommended that this real property be dedicated to the public for right-of-way purposes; and

WHEREAS, the Board of County Commissioners finds that it is in the public interest to dedicate and accept the herein-described county-owned property for public road right-of-way and utility purposes; and

WHEREAS, a proposed Dedication Deed, which incorporates the legal description of the land to be dedicated, is attached hereto as Exhibit E and incorporated herein by this reference:

### NOW THEREFORE, IT IS HEREBY ORDERED as follows:

- 1. The Board of County Commissioners, on behalf of Columbia County, hereby dedicates the herein-described property as additional public right-of-way for public road and utility purposes forever as a County road, and authorizes Tony Hyde, Chair, to execute the Dedication Deed, a copy of said deed being attached hereto as Exhibit E.
- 2. The Board of County Commissioners, on behalf of Columbia County, hereby accepts the above-described property as additional public right-of-way along Gable Road

at its intersection with Bachelor Flat Road for public road and utility purposes forever as a County road.

- 3. The Dedication Deed and this Order shall be filed with and recorded by the County Clerk in the Columbia County Deed Records without costs, and a copy of this Order shall be filed in the County road jacket for Gable Road.
- 4. The cartographer for the Assessor's office shall include this property in the named right-of-way.




