WHEREAS, the Columbia County Road Department published an invitation to bid for the overlay of Gable Road and Old Portland Road, and Scappoose-Vernonia Road in the St. Helens Chronicle and the Daily Journal of Commerce, on March 22, 2002, and March 23, 2002; and

WHEREAS, on Thursday, April 4, 2002, five bids were received for the Gable Road and Old Portland Road Overlay project, and six bids were received for the Scappoose-Vernonia Overlay project; and

WHEREAS, on Thursday, April 4, 2002, at 10:00 a.m., said bids were opened and read publically, said bids having been submitted by the following bidders in the following amounts:
