ORDER NO. 49-02

WHEREAS, on March 29, 2000, the Board of County Commissioners approved Order No. 27-2000, In the Matter of Authorizing Certain Positions Held within Columbia County to Enforce Certain Statutes, Administrative Rules, Ordinances, Orders and Resolutions, and Provisions Thereof; and

WHEREAS, subsequent changes in personnel within the Columbia County Sheriff's office requires that additional deputies be given authority under the Columbia County Enforcement Ordinance, Ordinance No. 92-15, to enforce certain statutes, rule, ordinances, orders and resolutions, and provisions thereof, covered by the Enforcement Ordinance, while the authority granted to other personnel should be revoked; and

WHEREAS, Deputies David W. Peabody, Sr., Keith Freels and Pat Anderson should be granted authority under the Columbia County Enforcement Ordinance; and

WHEREAS, the Letters of Authority previously issued to Lt. Randy Sparks, Deputy Larry Knowles and Deputy Joel Simmons, who have left the Sheriff's Office, should be revoked;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

1) Deputies Peabody, Freels and Anderson are granted authority and jurisdiction over, and may enforce, those statutes, administrative rules, ordinances, orders and resolutions, and provisions thereof, as referenced below, upon issuance of a Letter of Authority by the Board of County Commissioners.

2) The Letters of Authority previously issued to Lt. Sparks and Deputies Knowles and Simmons are hereby revoked.

3) The title to Exhibit A attached to Order No. 27-2000, and that section thereof pertaining to the Columbia County Sheriff, are hereby amended as follows:
