WHEREAS, on October 14, 2002, William and Elizabeth Pugh submitted a check to Columbia County in the amount of \$545.00, the sum of \$500.00 to purchase this parcel and the sum of \$45.00 to cover recording and handling fees;

WHEREAS, pursuant to ORS 275.225, notice of private sale was published in a newspaper of general circulation on October 23, 2002, and more than 15 days has elapsed since publication of said notice; and

WHEREAS, no further offers have been received by the County pursuant to this notice;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

- 1. Pursuant to ORS 275.225, the Board authorizes the sale of the above-described property to William and Elizabeth Pugh for \$500.00.
- 2. The Board of County Commissioners shall execute the Quitclaim Deed for Tax Account No. 01-01 3212-034-02100 to William J. Pugh and Elizabeth M. Pugh, a copy of which is attached hereto as Attachment 1 and by this reference incorporated herein, for the sum of \$500, receipt of which is hereby acknowledged.
