In the Matter of Conveying Certain County ) Owned Real Properties to the City of Vernonia )

**ORDER NO. 90 - 2002** 

WHEREAS, ORS 271.310(1) authorizes Columbia County to sell, exchange, convey or lease their interest in certain real property not needed for public use to any governmental body whenever the public interest may be furthered, the consideration for such transfer being cash or real property, or both; and

WHEREAS, in letters dated September 23, 2002, and October 6, 2002, Vernonia City Administrator Michael Sykes requested that the Board of County Commissioners transfer title to eight parcels of County-owned property located within the City limits to the City of Vernonia; and

WHEREAS, the eight County-owned parcels are described and given a current assessed value as follows:
