The Board of County Commissioners for Columbia County, Oregon ordains as follows:

SECTION 1. TITLE.

This ordinance shall be known as Ordinance No. 93-7.

SECTION 2. AUTHORITY.

This ordinance is adopted under the authority of ORS 203.035, 197.175, 197.610 and 197.615.

SECTION 3. PURPOSE.

The purpose of this ordinance is to create an Airport Industrial designation within the Columbia County Comprehensive Plan.

SECTION 4. AMENDMENT.

The Columbia County Comprehensive Plan is amended by the addition of the following to the GOALS and POLICIES of the ECONOMY section of the Comprehensive Plan:

POLICIES: It shall be a policy of the County to:

"13. Encourage industry which needs or can benefit from the locational advantages of an airport and its facilities, to locate adjacent to one of the airports in the County. Create an Airport Industrial district to facilitate this policy."

SECTION 5. FINDINGS.

Findings of fact and conclusions of law in support of this amendment are attached hereto, labeled Exhibit "A" and incorporated herein by this reference.

SECTION 6. SEVERABILITY.

If any provision of this ordinance, including Exhibit "A", is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such provision shall be deemed a separate, distinct and independent provision and such holding shall not affect the remaining portions thereof.

SECTION 7. EMERGENCY CLAUSE.

This ordinance being immediately necessary to maintain the public health, safety and welfare, an emergency is declared to exist and this ordinance shall take effect immediately upon its adoption.

Columbia County Planning Director Courthouse, St. Helens, OR 97051

REQUEST:

To amend the text of the Columbia County Comprehensive Plan to add a Policy to the Economy section of the Plan recognizing and permiting Airport Industrial zoning.

BACKGROUND:

This amendment would add the following to the GOALS and POLICIES of the ECONOMY section (p. 84) of the Columbia County Comprehensive Plan:

POLICIES: It shall be a policy of the County to:

"13. Encourage industry which needs or can benefit from the locational advantages of an airport and its facilities, to locate adjacent to one of the airports in the County. Create an Airport Industrial district to facilitate this policy."

This Comprehensive Plan text amendment includes an exception to Statewide Goal 14 (Urbanization) to allow "urban" industrial uses outside of urban growth boundaries. The Planning Commission recommends approval of this amendment. A concurrent change would add a new "Airport Industrial" (AI) zone to the Columbia County Zoning Ordinance to implement this amendment. Related files are TA 5-93, PA 1-93 and ZC 5-93.

FINDINGS:

This request is being processed under the GOALS and POLICIES of the ADMINISTRATIVE PROCEDURES section of the Comprehensive Plan. applicable sections of the Plan are as follows (p. 5):

"POLICIES:

- Provide a framework by which the Comprehensive Plan may be reviewed, revised and amended. Amendments to the Comprehensive Plan and its implementing ordinance(s) shall be in accordance with the following procedures and guidelines:
 - Amendments may be initiated by the Board of Commissioners, the Planning Commission, the Planning Director or the owner(s) of the affected property."
- This amendment to the text of the Comprehensive Plan Finding 1: was initiated by the Planning Director.

Continuing with Administrative Procedures Policy 5 of the Comprehensive Plan:

"C. Revisions or amendments will follow the same process as initial adoption - CPAC review, Planning Commission public hearing and recommendation, and Board hearing and adoption of revisions or amendments."

Finding 2: This process will be followed in processing these amendments to the Comprehensive Plan.

Continuing with Administrative Procedures Policy 5 of the Comprehensive Plan:

"E. For legislative amendments, notice of the public hearing and a copy of the proposed amendment will be mailed to all Citizen Planning Advisory Committees and interested parties at least 10 days prior to the first scheduled public hearing."

Finding 3: The above notices were mailed to all active CPACs, listed members of inactive CPACs, and interested parties at least 10 days prior to the Planning Commission hearing of June 7, 1993. In addition, a Notice of Public Hearing was published twice in the Chronicle and Spotlight newspapers. Notice included a statement that an exception to Statewide Goal 14 (Urbanization) was being taken.

Continuing with the Administrative Procedures Policies of the Comprehensive Plan:

"7. Existing ordinances and regulations will be amended and new ordinances and regulations shall be adopted to implement this plan as appropriate."

Finding 4: The Columbia County Zoning Ordinance is being amended concurrently, adding a new Airport Industrial district to implement these amendments to the Comprehensive Plan. See file TA 4-93.

COMMENTS:

No comments have been received from interested parties or government agencies as of the date of this staff report (June 9, 1993).

CONCLUSION AND RECOMMENDATION:

Based upon the above findings, the Planning Commission and staff recommend approval of this legislative amendment to the text of the Columbia County Comprehensive Plan.
