The Board of County Commissioners for Columbia County, Oregon, ordains as follows:

SECTION 1. TITLE.

This Ordinance shall be known as Ordinance No. 2013 -3.

SECTION 2. AUTHORITY

This Ordinance is adopted pursuant to ORS 203.035.

SECTION 3. PURPOSE.

The purpose of this Ordinance is to amend the Homeland Security and Emergency Management Commission Ordinance to allow appointment of Commission members by motion of the Board of County Commissioners.

SECTION 4. HISTORY.

The Board of County Commissioners approved Ordinance No. 2008-2, adopting the Columbia County Homeland Security and Emergency Management Commission Ordinance on July 23, 2008. Section I.C of the Ordinance requires that appointments of members be made by order of the Board of Commissioners. Due to frequent changes in the membership of the Commission, the Director of Emergency Management recommends that the Ordinance be amended to authorize appointments by motion of the Board.

SECTION 5. AMENDMENT AND AUTHORIZATION.

The Board of County Commissioners hereby amends Section I.C. of the Columbia County Homeland Security and Emergency Management Commission Ordinance to read as follows:

"C. The HSEMC shall consist of one member from each of the disciplines/geographical areas, as listed below, after nomination and appointment by the Board of County Commissioners (hereinafter referred to as the "Board"). ~~Appointment shall be made by order of the Board.~~"

SECTION 6. SEVERABILITY.


If for any reason any court of competent jurisdiction holds any portion of this Ordinance, or any portion therein, to be invalid, and such holding is upheld on any appeal, such portion shall be deemed a separate, distinct and independent portion. Any such holding shall not affect the validity of the remaining portions.

SECTION 7. SCRIVENER'S ERRORS.


Any scrivener's error in this Ordinance may be corrected by an order of the Board of County Commissioners.






