ORDINANCE NO. 94-1

The Board of County Commissioners for Columbia County, Oregon ordains as follows:

SECTION 1. TITLE.

This ordinance shall be known as Ordinance No. 94-1. It also may be cited and referred to as the Columbia County Justice of the Peace Ordinance.

SECTION 2. AUTHORITY.

This ordinance is adopted pursuant to the authority of ORS 203.035 and ORS 51.020.

SECTION 3. PURPOSE.

The purpose of this ordinance is to abolish the Vernonia Justice of the Peace District and expand the boundaries of, and rename, the Clatskanie Justice of the Peace District to include the area formerly included in the Vernonia District.

SECTION 4. VERNONIA JUSTICE OF THE PEACE DISTRICT ABOLISHED.

The Vernonia Justice of the Peace District consisting of the following precincts:

Vernonia 1;	Vernonia 5;
Vernonia 2;	South Mist;
Vernonia 3;	North Mist;
Vernonia 4;	

is hereby abolished.

SECTION 5. CLATSKANIE JUSTICE OF THE PEACE DISTRICT EXPANDED.

The Clatskanie Justice of the Peace District is expanded to consist of the following precincts:

Clatskanie 1;	Vernonia 1;
Clatskanie 2;	Vernonia 2;
Clatskanie 3;	Vernonia 3;
South Clatskanie;	Vernonia 4;
North Clatskanie;	Vernonia 5;
Marshland;	South Mist;
Quincy;	North Mist.

SECTION 6. JUSTICE OF THE PEACE DISTRICT RENAMED.

The Clatskanie Justice of the Peace District is hereby renamed the Clatskanie-Vernonia Justice of the Peace District.

SECTION 7. SEVERABILITY.

The provisions of this ordinance are severable. If any provision of this ordinance is determined to be invalid by a court of competent jurisdiction, such provision shall be considered a separate, distinct and independent provision and the decision shall not affect the validity of the remaining portions hereof.

SECTION 8. EMERGENCY CLAUSE.

This ordinance being immediately necessary for the public health, safety and welfare of the citizens of Columbia County, an emergency is declared to exist and this ordinance shall take effect on January 19, 1994.
