ORDINANCE NO. 92-9

The Board of County Commissioners for Columbia County, Oregon ordains as follows:

## SECTION 1. TITLE.

This ordinance shall be known as Ordinance No. 92-9.

## SECTION 2. PURPOSE.

The purpose of this ordinance is to adopt a fee schedule for the services provided by the Columbia County Planning Department.

### SECTION 3. AUTHORITY.

The ordinance is adopted pursuant to ORS 203.035 and 215.416. It is also subject to ORS 203.115.

#### SECTION 4. ADOPTION.

The fee schedule labeled Exhibit "A", attached hereto and incorporated herein by this reference is adopted for services provided by the Columbia County Planning Department.

#### SECTION 5. AMENDMENT.

Subject to ORS 203.115 and 215.416, the fee schedule attached as Exhibit "A" may be amended by order or resolution of the Board.

#### SECTION 6. REPEALER.

Ordinance Nos. 87-3 and 90-6 are repealed. All previously adopted ordinances, resolutions or parts thereof in conflict with this ordinance, to the extent of such conflict and no further, are also hereby repealed.

### SECTION 7. SEVERABILITY CLAUSE.

If, for any reason, any portion of this ordinance is held invalid or unconstitutional by any court of competent jurisdiction, such portion of the ordinance shall be deemed a separate, distinct

and independent portion and such holdings shall not affect the validity of the remaining portions thereof.

# SECTION 8. EMERGENCY CLAUSE.

This ordinance, being immediately necessary for the health, safety and welfare of the citizens of Columbia County, an emergency is declared to exist, and it shall become effective on passage.
