THE BOARD OF COUNTY COMMISSIONERS FOR COLUMBIA COUNTY, OREGON  
ORDAINS AS FOLLOWS:

Section I. No motor vehicles, combination of vehicles, including a semi-trailer or two or more trailers, or hauling other loads including but not limited to logs, poles, or otherwise, in excess of seventy-five (75) feet in length overall shall enter or travel upon any public right-of-ways of Columbia County without first obtaining a permit for such purposes from the Columbia County Roadmaster.

Section II. All vehicles or combinations thereof described in Section I must be escorted and preceded on the roadway by a "pilot vehicle" or other "flagger" in a manner prescribed by the Roadmaster.

Section III. The Roadmaster shall be authorized to issue permits required by this ordinance and shall be authorized to set stan-

standards for the operation of vehicles described in Section I and escorts, pilot vehicles, or other flaggers required in Section II. The Roadmaster may impose such other conditions as deemed necessary for the public health, safety, and welfare of citizens in Columbia County, upon the operator and owners of vehicles described in Sections I and II. All such standards and conditions shall be written upon or affixed to said permit.

Section IV. Permits and written conditions or standards issued to vehicles described in this ordinance must be carried in said vehicle and shall display the same upon demand of any police officer, judicial officer, or County Roadmaster.

Section V. Penalties for violations of this ordinance shall be applicable to owners and operators of vehicles described in this ordinance and shall be those provided in ORS 483.997.

Section VI. This ordinance being necessary for the immediate protection and maintenance of County roads and for the public
