The Board of County Commissioners for Columbia County, Oregon ordains as follows:

SECTION 1. AUTHORITY.

This ordinance is adopted pursuant to ORS 203.035, 810.010(2), 810.160 and 810.210(2).

SECTION 2. TITLE.

This ordinance shall be known as Ordinance No. 89-4

SECTION 3. PURPOSE.

The purpose of this ordinance is to provide a procedure for the prohibition of stopping, standing and/or parking on and along public and county roads in Columbia County, Oregon.

SECTION 4. APPLICATION.

This ordinance applies to all county roads, as defined by ORS 368.001(1), local access roads, as defined by ORS 368.001(3), and trails, as provided by ORS 368.021(2). It also includes land within county-owned and/or publicly dedicated rights-of-way even if not actually or completely in use for road purposes. However, the Board of County Commissioners shall only take action involving local access roads or trails within a city if the city governing body consents to the action.

SECTION 5. IMPLEMENTATION.

The Board of County Commissioners may prohibit stopping, standing and/or parking on and along roads subject to this ordinance by adoption of an order or resolution which is to be entered in the Commissioners' Journal. Such resolution or order shall become effective and have the force of law when traffic control devices are placed or erected giving notice of such prohibition in conformance with the state manual and specifications established under ORS 810.200.

SECTION 6. PENALTIES AND EXEMPTIONS.

Stopping, standing and/or parking a vehicle where prohibited by an order or resolution as described in Section 5 above is prohibited by ORS 811.550(14), (20) and/or (22), is subject to the exemptions specified in each of those subsections, and is in violation of and subject to the penalties described in ORS 811.555.

SECTION 7. SEVERABILITY.

If any provision of this ordinance is for any reason held to be invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed to be a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.

SECTION 8. REPEALER.

All previously adopted ordinances, resolutions or parts thereof in conflict with this ordinance, to the extent of such conflict and no further, are hereby repealed.

SECTION 9. EMERGENCY.

This ordinance being immediately necessary to maintain the public health, safety and welfare, an emergency is declared to exist and this ordinance takes effect on April 26th , 1989.
