O R D I N A N C E

THE BOARD OF COUNTY COMMISSIONERS FOR COLUMBIA COUNTY, OREGON ORDAINS
AS FOLLOWS:

SECTION I - Title: Undertaking for certain County officials

SECTION II - Authority: ORS Chapter 41, House Bill 2104 and ORS 204.020 al-
lows the Columbia County Board of Commissioners, hereinafter, the Board, to
require, by ordinance, for the filing by each officer under ORS 204.005 (1)
of an official undertaking in a reasonable amount with the County governing
body, with such surety as the governing body determines necessary, prior to
that officer assuming office.

SECTION III - Purpose: To comply with ORS 204.020 requiring the filing by
each officer of an official undertaking in a reasonable amount with the
County governing body, with such surety as the governing body determines
necessary.

SECTION IV - Payment of premiums on bonds: The Board shall pay out of the
general fund the premiums on corporate surety bonds furnished by Columbia
County Association of Independent Insurance Agents as follows:

Sheriff -	\$ 10,000.00
County Clerk -	10,000.00
County Assessor -	5,000.00
County Treasurer -	50,000.00
County Surveyor -	5,000.00
County Commissioner -	5,000.00

SECTION V - Severability: If any provision of this ordinance is for any
reason held invalid or unconstitutional by any court of competent jurisdic-
tion, such portion shall be deemed a separate, distinct and independent
provision and such holdings shall not affect the validity of the remaining
portions thereof.

SECTION VI - Emergency Clause: This Ordinance being necessary for the immediate preservation of public peace, health and safety, an emergency is declared to exist and this Ordinance shall take effect upon its adoption.
