

AMENDMENT 2 to  
COLUMBIA COUNTY RETIRED SENIOR VOLUNTEER DONATION AGREEMENT  
BY AND BETWEEN COLUMBIA COUNTY AND  
UNITED WAY OF COLUMBIA COUNTY

THIS AMENDMENT 1 is to the AGREEMENT made and entered into by and between Columbia County, a political subdivision of the State of Oregon, hereinafter referred to as "County", and United Way of Columbia County, an Oregon non-profit corporation, hereinafter referred to as "Donee", effective July 27, 2022 (the "Original Agreement").

WHEREAS, Effective June 30, 2022, the Columbia River Fire & Rescue no longer partnered with AmeriCorp for the Retired Senior Volunteer Program ("RSVP") in Columbia County; and

WHEREAS, Donee manages older adult programs in Columbia County and agreed to manage the RSV Program in Columbia County pursuant to the Original Agreement; and

WHEREAS, the Original Agreement provided that Donee would seek funding from AmeriCorp for the funding when it was available, and such funding is not available for Fiscal Year 2025-2026; and

WHEREAS, Columbia County budgeted funds for the RSVP in the amount of \$30,000 in Fiscal Year 2025-2026 as a stop-gap measure for the fiscal year;

NOW, THEREFORE, it is hereby agreed as follows:

1. The Original Agreement is amended as follows:

Paragraph 2 is amended to read as follows:

"2. The County agrees to donate to Donee \$30,000 to fund Donee's Senior Volunteer Program through June 30, 2026. Payment will be made upon signature of this Amendment 2. If Donee does not use these funds in its Senior Volunteer Program, Donee shall return such funds to the County. This Agreement is subject to the appropriation of funds by the County and may be terminated for Fiscal Year 2025-2026 upon 30 days' notice from the County."

2. This Amendment 2 is effective on the date last signed, below, and shall be retroactive to July 1, 2025.
