

AMENDMENT 3 TO
PERSONAL SERVICES CONTRACT
BY AND BETWEEN COLUMBIA COUNTY, OREGON AND MEDTRUST LLC
FOR MEDICAL AND MENTAL HEALTH SERVICES IN THE COLUMBIA COUNTY JAIL

This Amendment 3 is to the Agreement made and entered into by and between COLUMBIA COUNTY, a political subdivision of the State of Oregon, hereinafter referred to as "County or "COUNTY", and MEDTRUST LLC, hereinafter referred to as "Contractor" or "CONTRACTOR". COUNTY and CONTRACTOR are jointly referenced as "Parties" or "PARTIES".


WHEREAS, on November 20, 2023, the parties entered into an Agreement for Medical and Mental Health Services at the Columbia County Jail; and

WHEREAS, the parties desire to extend the agreement for a period of one year; and

NOW, THEREFORE, it is hereby agreed as follows:

1. The Personal Services Contract by and between Columbia County and the MEDTRUST, LLC, is hereby amended to extend the completion date to November 30, 2026. County shall pay Contractor on a fee for service basis for the term beginning December 1, 2025, and ending November 30, 2026, in an amount not to exceed \$1,857,655.22, plus costs for those items paid by Contractor and reimbursed by the County, in accordance with the Contract. Compensation shall be billed and paid in accordance with Exhibit "A".
2. This amendment shall take effect on the date last signed below.
3. Except as expressly amended herein, the Personal Services Contract by and between Columbia County and MEDTRUST, LLC, as amended, remains in full force and effect.
