CALL TO ORDER/PLEDGE OF ALLEGIANCE

Commissioner Smith called this meeting to order at 10:01 am and led the Pledge of Allegiance.

APPROVE AGENDA

Commissioner Garrett moved to amend the agenda by adding executive session first, followed by discussion items and visitor comments. Commissioner Magruder seconded. **Vote:** KJS/MM/CG all in favor. Motion Approved.

EXECUTIVE SESSION

The Board of Commissioners recessed the regular scheduled meeting to enter an executive session with Amy Hansford, Finance Director.

1. Riley Baker, General Services Director, is here asking for directions regarding Courthouse and Annex Boilers. Both boilers are no longer functioning and need to be replaced. There is a chance of a leak in the concrete under the elevator, but it won't be verifiable until we replace the boilers. Two more bids are coming in on Friday, and we will need to decide on one or two boilers and which company to go with. Staff are directed to gather the bids, check on preordering the boilers, and see if expedited shipping is available for the other bids received.
2. Amy Hansford, Finance Director, is here looking to see if the Board would like to buy back two furlough days. Commissioner Garrett moved to buy back two furlough days, and Commissioner Magruder seconded. **Vote:** KJS/MM/CG all in favor. Motion Approved.
3. Jaime Aanensen, Public Health Director, is here requesting Board Support on the Advocacy Letter. After the discussion, Jaime will return next week with a letter that is not a stock response and provides detailed information about Columbia County Public Health.
