X		The listed dog(s) shall be confined within the home or an adequately padlocked fenced yard when not on a leash and under the control of an adult person. Adequate fence yard is defined as one that prevents any escape.
		The listed dog(s) shall be microchipped and the chip number registered to the county.
		The listed dog(s) shall be spayed or neutered within 60 days.
		Posting of "WARNING DANGEROUS DOG" sign shall be displayed on the entrance to any location that the dog(s) is being kept.
X		The listed dog(s) shall be kept current on both dog licenses and rabies vaccinations.
X		The Keeper shall keep the county informed of the dog's physical address, any changes in ownership or disposal of the dog within 10 days. Any new owner will need to license the dog and abide by the restrictions on this dog.
X		The keeper of the dog(s) shall report to Columbia County Animal Control incidents of any bite regardless of human or other animal within 24 hours, regardless of victim.
		The keeper shall be required to secure the dog in a locked fenced yard, crate, kennel, or in a closed room in the dwelling when nonfamily members are on the property. Non-family members are defined as any persons who does not reside in the home.
X		The keeper shall advise non-emergency dispatch for the geographic area, if the dog escapes from the keepers care within 10 minutes of the escape and shall notify the dispatcher of the dogs' designation as potentially dangerous.
X		The keeper shall allow Animal Control entry to the property the dogs reside to verify compliance with the sanctions listed in this notice.
		The listed dog shall be maintained within a six-foot covered kennel, secured with a padlock when outside and off leash.
		The listed dog shall be maintained on a harness when being walked on a leash.
		The listed dog shall be muzzled when walked on a leash off the dog owner's property.
		The listed dog is barred from off leash dog parks and beaches.
		The keeper shall provide a mailbox in a location that assures the safe delivery of mail and/or packages away from the listed dog.



## COURT SANCTIONS UNDER ORS 609.990

The defendant has been found guilty of or has plead no contest to the offense of violation of ORS 609.095 dog as a public nuisance. In addition, the court may determine that the actions of the dog at the time of the violation met the requirements to determine that the dog(s) actions were that of a potentially dangerous dog as defined under ORS 609.035.

ORS 609.990 provides that in addition to any fine imposed for violation of ORS 609.095 the court may impose reasonable restrictions on the keeping of a dog to ensure the safety or health of the public. As such the court issues the included sanctions to be imposed upon any person owning or keeping the dog(s).

### NON-COMPLIANCE INFORMATION

Failure to comply with the restrictions issued by the courts, can result in additional citations for maintaining a dog as a public nuisance and the dog being impounded.
