

AMENDMENT 1 TO  
PUBLIC SERVICES CONTRACT (ORS CHAPTER 279B)  
BY AND BETWEEN  
COLUMBIA COUNTY  
AND  
WASTE CONNECTIONS OF OREGON, INC. DBA HUDSON GARBAGE SERVICE  
  
FOR TRANSPORTATION AND DISPOSAL OF SOLID WASTE

This Amendment 1 to the Agreement is made and entered into by and between Columbia County, a political subdivision of the State of Oregon, hereinafter referred to as "County", and Waste Connections Of Oregon, Inc. dba Hudson Garbage Service, hereinafter referred to as "Contractor", with an effective date of March 6, 2021.

WHEREAS, Effective March 6, 2021, the parties entered a five-year agreement for Transportation and Disposal of Solid Waste; and

WHEREAS, that Contract allowed for one extension for up to five years; and

WHEREAS, the parties wish to take advantage of that extension.

NOW, THEREFORE, it is hereby agreed as follows:

1. The term of the contract is extended through March 6, 2031.
2. Effective March 1, 2026 compensation to the contractor for the transportation and disposal of solid waste will no longer be based on the prices set forth in Attachment A.1. of Exhibit A.
3. Effective March 1, 2026 the price per ton for solid waste transportation and disposal shall be \$50.50.
4. Effective March 1, 2027 the price per ton for solid waste transportation and disposal shall be \$53.50.
5. On March 1, of each of the following three years (2028/2029/2030) the price per ton for solid waste transportation and disposal shall be adjusted by the percentage change in the Bureau of Labor Statistics, Consumer Price Index for All Urban Consumers (CPI-U), West Region, Size Class B/C during the 12 month period ending December 31 of the previous year. If this index is discontinued the Consumer Price Index for All Urban Consumers (CPI-U), West Region shall be used in its place.

- 6. This Amendment is effective on the date last signed below.
- 7. This Amendment may be executed in several counterparts (facsimile or otherwise) all of which when taken together shall constitute one agreement binding on all Parties, notwithstanding that all Parties are not signatories to the same counterpart. Each copy of this Amendment so executed shall constitute an original.
- 8. The Parties agree that signatures showing on PDF documents, including but not limited to PDF copies of the Agreement and amendments, submitted or exchanged via email are "Electronic Signatures" under ORS Chapter 84 and bind the signing Party and are intended to be and can be relied upon by the Parties. The County reserves the right at any time to require the submission of the hard copy originals of any documents.
- 9. Except as expressly amended herein, all other terms of the agreement remain in full force and effect.

IN WITNESS WHEREOF the parties have caused this Amendment No. 1 to be executed and to hereby warrant and represent that their respective officers, whose signatures appear below, have been and are on the date of this Amendment authorized by all necessary and appropriate legal action to execute this Amendment.
