CALL MEETING TO ORDER

Commissioner Smith called this meeting to order at 10:00 am and led the Pledge of Allegiance.

APPROVE AGENDA

VISITOR COMMENTS - 3 MINUTE LIMIT

- Representing ASFME 1442, Courthouse Employees, Erin O’Connell, Rainier. Read the Columbia County’s mission, vision, and value statement into the record. She called to attention the last sentence. The Board of Commissioners reaffirms its commitment to maintaining a safe, respectful, and professional workplace for all county employees and to upholding the public trust.
