

**AMENDMENT # 5 to
INTERGOVERNMENTAL AGREEMENT # 90G000254**

This is Amendment No. 5 to 90G000254, dated September 11, 2013, as amended from time to time (“Intergovernmental Agreement”) between the State of Oregon, acting by and through its Department of Consumer and Business Services (“DCBS”), Building Codes Division (“BCD”) and Columbia County (“County”). This Amendment is effective upon signature of the parties (Amendment Effective Date).

RECITALS

The purpose of Amendment 5 is to:

1. Update DCBS’ Contract Administrator.
 2. Update Section I. Purpose to extend the expiration date.
 3. Update Section II. Statement of Work.
1. The Intergovernmental Agreement is amended as follows (new language is indicated by **underlining and bold** and deleted language is indicated by ~~striketrough~~):

This agreement is entered into by Building Codes Division and Columbia County to provide Building Official services, Commercial and Residential Fire Life-Safety, Structural, Electrical, Plumbing and Mechanical plan review and inspections for each other.

TERM OF AGREEMENT

This Agreement shall become effective on the date at which every party has signed this Agreement. This Agreement shall expire on **June 30, 2028** ~~June 30, 2026~~ unless terminated early in accordance with section VI.

c) Section II. Statement of Work is amended as follows:

II. STATEMENT OF WORK

Columbia County shall:

1. Contact DCBS provided Building Official when Sservices are required.
2. Provide the Building Official any required information, plans, permits, inspections reports or other documents, as requested.
3. Unless other specific arrangements are made with the Building Official, -send Commercial and Residential Structural, Plumbing, Electrical and Mechanical plans for plan review to:

2. Except as expressly amended above, all other terms and conditions of original Agreement are still in full force and effect. County certifies that the representations, warranties and certifications contained in the original Agreement are true and correct as of the Amendment Effective Date and with the same effect as though made at the time of this Amendment.
