

AMENDMENT 5 TO
PUBLIC SERVICES CONTRACT (ORS CHAPTER 279B)
BY AND BETWEEN
COLUMBIA COUNTY
AND
THE ACT 1 GROUP, INC. DBA ATIMS
(ADVANCED TECHNOLOGY INFORMATION MANAGEMENT SYSTEMS)
FOR JAIL MANAGEMENT SYSTEM SOFTWARE AND SOFTWARE SUPPORT
AND MAINTENANCE SERVICE IN THE COLUMBIA COUNTY JAIL

This Amendment 5 to the Agreement is made and entered into by and between COLUMBIA COUNTY, a political subdivision of the State of Oregon, hereinafter referred to as "County", and THE ACT 1 GROUP, INC. DBA ATIMS (ADVANCED TECHNOLOGY INFORMATION MANAGEMENT SYSTEMS), hereinafter referred to as "Contractor" or "ATIMS", dated December 23, 2015.

WHEREAS, the parties desire to extend the contract one additional year and to modify contractor's services to cover programing required to implement a transaction-based interface between the County's system and the Oregon Department of Corrections victim notification application. The parties further desire to increase the professional service fees due to contractor to cover the costs for the work necessary to complete these additional services;


NOW, THEREFORE, it is hereby agreed as follows:

1. Section 2, Completion Date, is amended to extend the Term of the Original Agreement to August 14, 2026. This change is retroactive to August 14, 2024.
2. An additional agreement between the parties is attached hereto as Exhibit 1. Exhibit 1 contains confidential proprietary information of the Contractor that has been provided to the County in confidence. The County has committed in good faith to maintain that confidentiality until this proprietary information is released by the Contractor.
3. Except as specifically amended herein, the Public Services Contract by and between Columbia County and the Act 1 Group, Inc., DBA ATIMS (Advanced Technology Information Management Systems) as previously amended by amendments 1 through 4, remains in full force and effect.

4. This Amendment 5 is effective on the date last signed below but the amendment to Section 2 of the contract shall be retroactive to August 14, 2024.
