The purpose of the hearing is consider an amendment to the Land Development Services Fee schedule, which includes: Building fees (including Structural, Mechanical, Plumbing, Manufactured Housing and other miscellaneous fees), Planning fees, and On-Site Sewage fees. The current fee schedule provides for an annual increase in accordance with the Consumer Price Index (CPI-U) for the Portland-Salem Metro Area. That index has been replaced by the CPI-U West index. The proposed amendment therefore updates the fee schedule to refer to the current CPI-U West index for the annual inflationary adjustment. Moreover, because of the COVID-19 pandemic, the County chose not to apply the CPI increase to its fees in 2020. This year's fees will therefore reflect a 2.7% increase for 2019 and a 1.7% increase for 2020, for a total increase of 4.4%.
