FIVE-YEAR LOCAL OPTION TAX FOR CEMETERY OPERATIONS

Shall District renew levy of \$0.05 per \$1,000 of assessed value for an additional five years for operations/equipment beginning FY2026-2027? This measure renews current local option taxes.

Summary 175 words which concisely and impartially summarizes the measure and its major effect.

This measure authorizes Rainier Cemetery District to impose a local option property tax of \$0.05 per \$1,000 of assessed value each year for five years, beginning with the 2026-2027 fiscal year.

With this measure the District is asking for the continuation of a current levy which will expire on 7/1/2026. This District is not asking for an increase in your current property tax rate but rather a 5 year extension of an existing levy.

Approval of this measure authorizes Rainier Cemetery District to impose a local option property tax for five consecutive years. Tax revenues will be used to purchase and maintain equipment, perform maintenance, and continue full-time cemetery operations of twelve (12) cemeteries. Without the continuation of this additional revenue the District will be unable to replace necessary equipment and may be forced to reduce its operating hours and service levels.

All funds collected will be used exclusively for the purposes described.

For a home assessed at \$200,000, the estimated cost would be \$10.00 per year.

The proposed rate will raise approximately \$79,799 in 2026-2027, \$82,194 in 2027-2028, \$84,660 in 2028-2029, \$87,199 in 2029-2030 and \$89,815 in 2030-2031 for a total of \$423,667. The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of the estimate and may refect the impact of early payment discounts, compression and the collection rate.
