FIVE-YEAR LOCAL OPTION LEVY FOR PARK OPERATIONS

Shall Clatskanie Park and Recreation District impose \$0.10 per \$1,000 of assessed value for park operations beginning in 2027-2028?
This may cause property taxes to increase more than three(3) percent.

Summary 175 words which concisely and impartially summarizes the measure and its major effect.

The Clatskanie Park and Recreation District will use tax revenue from this measure for daily park maintenance, maintain and make repairs to aging infrastructure, including the swimming pool. To provide competitive wages to the park and pool staff. Without this additional revenue the district's ability to maintain the park and staff, including equipment could be in jeopardy. The proposed rate will raise approximately \$111,490 in 2027-2028, \$115,950 in 2028-2029, \$120,587 in 2029-2030, \$125,411 in 2030-2031 and \$130,427 in 2031-2032 for a total of \$603,865. The estimated cost for this measure is an ESTIMATE ONLY based on best information available from the County Assessor at the time of the estimate and may not reflect the impact of early payment discounts, compression and the collection rate

For a home assessed at \$400,000, the proposed levy will add an additional \$40.00 per year to the homeowner's tax bill or \$3.33 per month to a monthly mortgage payment.
