## Property Information and Summary

- File Number: V 25-02
- Applicant/Property Owner: Daniel Honeycutt
- Address: Located at 79943 Bodine Road in Clatskanie
- Tax Map ID/Tax Account: 4118-B0-00300/17254
- Zone: Primary Forest (PF-80)
- Size: Approximately 2.32 acres
- Proposal: The applicant is requesting a variance to the minimum 50' setback for a detached accessory structure to be located 30' instead of 50' from the side property line. This approval will legalize the unpermitted accessory structure in compliance with the Oregon Building and Fire Codes as well as County Zoning Ordinance.

## Recommendation

- Based on the research, analysis and Findings identified in the Staff Report, staff recommends that the Planning Commission **APPROVE** V 25-02 subject to the stated Conditions of Approval.

Brian Brust asks if both septic tanks were backfilled and confirmed they are decommissioned. Planning commission questions if they have been provided documentation that the tanks were back filled. Spencer advised the Planning Commission chair that they were moving out of order and advised Alta Lynch to open the record so that this can be discussed further. LDS Sanitarian does a site visit to confirm the tanks were pumped and backfilled properly.

Daniel Honeycutt (applicant) explains that he did have both tanks decommissioned.

Jonathan Barclay asks applicant when he purchased the property. Daniel answered that he was granted the property in 2020.

Brian Brust asks the applicant about utilities to the building. Daniel explained that there is currently no plumbing in the building. Brian then asks about the costs for the structure. Deb Jacob explains the process of the agriculture exempt process and there would be a recording fee for the deed restriction.

Alta Lynch asks the applicant if he would like a rebuttal. None
