**NOTICE IS HEREBY GIVEN** that Weyerhaeuser timber Holdings, Claruth Inc., Wilna Inc, and Franbea Inc. and Northwest Natural (NWN) have applied for a Conditional Use Permit (CU 25-169) for establishing three well pads for injection/withdrawal (IW) and one well pad for observation/monitoring (OM) of activities at the NWN's Mist Underground Natural Gas Storage Facility near Mist, Oregon. The IW well pads will be connected to the compressor station with underground pipelines and the OM well pad will not have any pipelines. The well pads will be developed on ~6-acres of the 4 affected PF-80 zoned tax lots 7500-00-04500/04700/04800/05000.
