Eligibility: All Oregonians age 12 years or older

Approved COVID-19 Vaccines		
Product Name	Doses	Acceptable Age Range
Pfizer/BioNTech	2 doses, 21 days apart	≥12 years
Moderna	2 doses, 28 days apart	≥18 years
Johnson & Johnson	1 dose	≥18 years

Parental or guardian consent is required to vaccinate people 12–14 years old, but it does not necessarily mean a parent or guardian has to be present at the time of vaccination. Written consent may be obtained in advance. You should contact the vaccine provider or vaccination clinic to determine whether a parent or guardian must be present.
