VISITOR COMMENTS - 3 MINUTE LIMIT

Truett Stolzenberg addressed the Board regarding the historical and legal status of Beaver Dike Road and Erickson Dike Road. He stated that discussions concerning these roads should focus on their legal classification and historical records rather than assumptions regarding historical funding arrangements. He referenced changes to Oregon county road laws enacted in 1981 and encouraged further examination of the roads' legal status and the process required to alter that status. A copy of his prepared comments was provided to the Board.

Nancy Ward, Columbia County Port Commissioner, commented in support of continued review of the historical documentation regarding the roads discussed by Mr. Stolzenberg. She acknowledged the extensive research conducted and noted the importance of resolving affected parties, including the Port and its tenants.
